

1. Modify the following texts so that the statements are true.

The sender and the receiver do not need to share any secret keys when $\begin{pmatrix} \text{symmetric} \\ \text{public key} \end{pmatrix}$ is used.

In order to verify a digital signature, it is needed the $\begin{pmatrix} \text{private key of the signer} \\ \text{public key of the signer} \\ \text{private key of the receiver} \\ \text{public key of the receiver} \end{pmatrix}$.

The key length in symmetric ciphers is $\begin{pmatrix} \text{shorter} \\ \text{longer} \end{pmatrix}$ than in public key ciphers.

In symmetric cipher, the encryption process is $\begin{pmatrix} \text{slower} \\ \text{faster} \end{pmatrix}$ than in public key ciphers.

$\begin{pmatrix} \text{Symmetric} \\ \text{Public key} \end{pmatrix}$ encryption uses $\begin{pmatrix} \text{the same key} \\ \text{different keys} \end{pmatrix}$ for encryption and decryption.

In hybrid encryption, the user data is ciphered using $\begin{pmatrix} \text{symmetric} \\ \text{public key} \end{pmatrix}$ algorithms.

In hybrid encryption, the $\begin{pmatrix} \text{private key of the sender} \\ \text{public key of the sender} \\ \text{private key of the receiver} \\ \text{public key of the receiver} \end{pmatrix}$ is used for encryption of $\begin{pmatrix} \text{user data} \\ \text{session key} \end{pmatrix}$.
